

**DURABLE POWER OF ATTORNEY
FOR
FEMALE INDUCED DEMENTIA**

Also known as
GOLD-DIGGER'S SYNDROME

NOTICE TO PERSON EXECUTING THIS DOCUMENT:

THIS IS AN IMPORTANT NON-LEGAL DOCUMENT. (But Hell, it should be legal.) IT IS BASED ON THE OBSERVATION THAT THE GOVERNMENT COURTS AND LAWS, WHICH ARE SUPPOSED TO PROTECT HUMAN RIGHTS, HAVE BECOME COMPLETELY INEFFECTIVE AND IN FACT ARE COMPLETELY DESTRUCTIVE TO THE RIGHTS OF MEN WHEN DEALING WITH WOMEN.

IT IS FURTHER BASED ON THE IDEA THAT A MAN'S FRIENDS ARE HIS BEST HOPE FOR PROTECTION. THEY SHOULD BE GIVEN THE POWER TO PROTECT HIM FROM HIMSELF AND AFTER THEY HAVE PROTECTED HIM, BE ABLE TO LAUGH AT HIS SORRY ASS FOR BEING SUCH A FOOL. THIS DOCUMENT CREATES A DURABLE POWER OF ATTORNEY OVER YOUR MONEY, BODY AND LOVE LIFE. BEFORE EXECUTING THIS DOCUMENT, YOU SHOULD KNOW THESE IMPORTANT FACTS.

1. THIS DOCUMENT MAY PROVIDE THE PERSON YOU DESIGNATE AS YOUR ATTORNEY-IN-FACT WITH BROAD POWERS TO HIDE YOUR MONEY, USE YOUR MONEY, IMPRISON YOU OR SIMPLY JUST KICK YOUR ASS UNTIL YOU COME TO YOUR SENSES.

2. FEMALE INDUCED DEMENTIA: "F-I-D"

A. BY EXECUTING THIS DOCUMENT, YOU ARE ACKNOWLEDGING THAT WHEN OVERCOME WITH LUST (You will call it "love" but come on dude, it's lust.) YOUR BRAIN IS DEPRIVED OF OXYGEN THUS RENDERING YOU MENTALLY INCAPABLE OF MAKING RATIONAL DECISIONS. This is referred to as "FEMALE INDUCED DEMENTIA."

4. YOUR AGENT SHALL HAVE THE POWER TO RETAIN THE AIDE OF FRIENDS, BROTHERS, UNCLES, AND COUSINS TO ASSIST IN THE EXECUTION OF HIS DUTIES.

5. DISPUTE RESOLUTION: Any dispute as to the use and execution of these powers by the Agent shall be brought to and adjudicated by a court of competent jurisdiction. A "court of competent jurisdiction" shall be deemed to be a bar/saloon/pub known to all parties. The judge shall be a male bartender with no fewer than five years experience. _____, (the principal), hereby appoints _____, (the agent), as the principal's true and lawful Gold-digger-attorney-in-fact (agent) for the principal.

**The agent(s) shall carry out the following acts under this instrument:
(Please put a check mark next to the options that apply.)**

1. If I am dating a woman more than 10 years my junior and/or has no money, my agent is authorized and directed to:

- Remind me that I am old fart who could never score a woman like that if I did not have fat stacks.
- Remind me that the only thing in my pants this girl wants is in fact my wallet.
- Get me drunk until alcohol washes away FID.
- Take me to a strip club to remind me that any woman can pretend to love me for money.
- Take me to a pastor/priest for confession (Be real, it is all about sinful lust.)
- Kick my ass.

2. If I decide to marry a woman over 10 years my junior and has less money than me:

- Skip straight to "kick my ass."

3. If I am dating a woman who has been divorced my Agent is authorized and directed to:

- Remind me that this girl has no problem dumping and fleecing any guy she deems to be an “asshole” and, hey, I am basically an asshole already.
- Hire a private detective to locate her ex and get the truth about this woman.
- Get me drunk until alcohol washes away FID.
- Take me to a strip club to remind me that there are plenty of women in the world.
- Take me to a pastor/priest for confession. (Yes, it is all about sinful lust.)
- Kick my ass.

4. If I begin dating a single mother my Agent is authorized and directed to:

- Leave me at home but take my credit card to a strip club and max it out buying lap dances for everyone in the club. (To get me used to paying for other’s guys’ irresponsible fun)
- Kidnap me, take away my nice clothes, nice car, spending money, and lock me in a room full of screaming kids with a legal notice of what will happen if I so much as yell at one to shut up.
- Get me drunk until alcohol washes away FID.
- Keep me the hell away from any pastor/priest. (Those bastards WILL throw my ass under the bus for a single mother.)
- Kick my ass.

5. If I start dating a stripper, my Agent is authorized and directed to:

- Public Notice: Tell everyone at my favorite bar(s), so that I not only get a round of high-fives, but there is public notice that I am in danger of developing FID.
- Get me to the free clinic for the preemptive round of penicillin.

6. If I fall in love and/or want to marry the stripper, my Agent is authorized and directed to:

- Kidnap me and force me to watch documentaries on STD’s until I come to my senses.
- Remind me that strippers are the Jedi Masters of FID.
- Take my credit card and all my friends to her strip club for a round of lap dances from her. (To eliminate the question of “who has and who hasn’t” and to remind me that I am boldly going where every man has gone before.)
- Take me to McDonalds. (To show that the meal may satisfy a hunger but, like her pussy, with this many served, I’m nothing special.)
- Kick my ass.

- ___ Kick my ass.
8. If I am dating, falling in love with, or wanting to marry a woman whom my Agent A) deems to be a Gold-digger and who is B) not younger than me and/or C) ugly/fat, my Agent is authorized and directed to:

- ___ Sign me up for psychiatric review.

- ___ Apply options from Paragraph 1
9. If I want to get back together with my girlfriend/wife who cheated on me
- ___ Go straight to “kick my ass”.
- ___ Keep me away from pastors or priests. (Those sons of bitches want me back in slave camp and will fuck me over faster than she fucked Chad/Tyrone.)
- ___ Castrate me. (I am obviously not using them anyway.)
10. If I want to get back together with a wife who divorced me:
- ___ Go straight to “kick my ass” with the following conditions:
Use my credit card to buy an expensive suite, expensive briefcase, rent a BMW, and bring a half-crazed crack whore to my house. Then proceed to kick me repeatedly in the groin while stealing my money and giving it to the crazy woman, while she hurls insults at me.
